

Programs that can help you *pay your energy bill*

Low Income Home Energy Assistance Program (LIHEAP)*

Applications now available until June 30, 2024.

LIHEAP helps customers pay for winter heating bills and medically-necessary cooling costs, even if heating is part of your rent. Income-eligible customers can receive an average of \$400 toward their PSE&G bill

If you apply for LIHEAP, you are also applying for USF.

Universal Service Fund (USF)*

Applications are accepted year-round.

USF helps make energy bills more affordable. Income-eligible customers can receive a \$5 to \$180 monthly USF credit toward their PSE&G bill. The USF Fresh Start Program (FSP) also offers forgiveness of past-due balances of over \$60.

New Jersey SHARES (NJ SHARES) Grants*

As of January 2024, the Payment Assistance Gas and Electric (PAGE) program will be administered by NJ SHARES.

NJ SHARES now includes three grants to help income-eligible households pay their overdue PSE&G bills: PAGE, NJ SHARES SMART Utility Assistance, and NJ SHARES Energy Assistance. Customers can receive multiple grants to apply toward their energy bill, depending on the balance owed. To qualify, you must meet the income limits and program guidelines. Applications are accepted year-round.
