

USF Agency Application Assistance



Customers can apply for the Universal Service Fund (USF) online at pseg.com/energyassistance or download an application at pseg.com/liheapapp and submit through an agency below **in the county where you live**.

To apply for these programs, the following documents are required:

- Social security cards (entire household) or 2023 filed income tax returns (not handwritten), if applicable
- Copy of lease, mortgage or property tax bill
- Most current PSE&G bill (all pages)
- Proof of income for the previous 30 days, entire household, 18 or older
- Identification for entire household, if applicable

- Facturas de PSE&G (todas páginas)
- Pruebas de ingresos de los 30 días previos, de toda la familia mayores de 18
- Identificación de toda la familia, si aplica
