TAKE NOTICE that, on September 27, 2019, Public Service Electric and Gas Company ("Public Service," "PSE&G" or the "Company") filed a Petition and supporting documentation with the New Jersey Board of Public Utilities ("Board") requesting a resetting of the Company's Electric and Gas Tax Adjustment Credits ("TAC"). If approved, this filing would decrease rates to be paid by the Company's electric customers by \$15.5 million annually and would decrease rates to be paid by the Company's gas customers by \$10.1 million annually. These changes are the result of adjustments to the TAC, which was designed to return net tax benefits from the Tax Cuts and Jobs Act of 2017, and other income tax related adjustments to customers. The proposed electric and gas TAC credits, if approved by the Board, are shown in Tables #1 and #2. The only customers that will experience an increase as a result of the TAC in this filing are those large users in the CSG ("Contract Service Gas") class, who will experience an increase of approximately 7.7%.

The approximate effects of the proposed change on typical electric and gas residential monthly bills, if approved by the Board, are illustrated in Tables #3 and #4.

Based on the filing, a typical residential electric customer using 740 kilowatt-hours per summer month and 6,920 kilowatt-hours on an annual basis would see a decrease in the annual bill from \$1,229.48 to \$1,223.20, or \$6.28 or approximately 0.51%.

Under the Company's proposal, a residential gas heating customer using 100 therms per month during the winter months and 610 therms on an annual basis would see a decrease in the annual bill from \$561.92 to \$559.10, or \$2.82 or approximately 0.50%.

Moreover, under the Company's proposal, a typical residential heating customer using 172 therms per month during the winter months and 1,040 therms on an annual basis would see a decrease in the annual bill from \$885.06 to \$880.24, or \$4.82 or approximately 0.54%.

The Board has the statutory authority pursuant to N.J.S.A. 48:2-21 to establish the TAC to levels it finds just and reasonable. Therefore, the Board may establish the TAC at a level other than that proposed by Public Service. As a result, the described charge may change based upon the Board's decision.
