Customers can apply for the Low Income Home Energy Assistance Program (LIHEAP) and Universal Service Fund (USF) online at pseg.com/energyassistance or download an application at pseg.com/liheapapp and submit through an agency below **in the county where you live.**

To apply for these programs, the following documents are required:

- Social security cards for every household member
- Copy of lease or mortgage
- Most current PSE&G bill
- Proof of one month of household income (within the past 30 days)
